

<u>FAIRFIELD GARAGE INTERPRETIVE HISTORICAL MARKER</u>—As mentioned on page one, our next interpretive historical marker will be dedicated at Noon on October 28th at the site of the former Fairfield Garage. Please join us on that day. If you are unable to make it that day, I have included below, a copy of the sign commemorating this part of Haddon Heights history.



Fairfeld Garage & Motor Company

This building, now the offices of Sensonics International, was built as the Fairfield Garage & Motor Company where ears were repaired, fueled, and sold by the Crecelius family. In the 1920s, Frederick W. Crecelius moved his family from South Philadelphia to Haddon Heights, where he and his sons, Frederick, Jr. and Edward, ran the company. By the 1950s, the business name changed to "Fairfield Automotive Supplies" and sold auto parts.

The name of the garage was derived from the area of town known as Fairfield Estates. When Haddon Heights was incorporated in 1904, its western boundary extended only to Bellmawr Avenue. The portion of town from Bellmawr Avenue to the Black Horse Pike remained part of Centre Township until 1925 before joining the Borough.

Above the garage there were six apartments that were called "cold water flats" because they didn't have any hot water piping. One of the families who lived there had a nine-year-old daughter, Beatrice Deuter, who met Kenneth D. Crecelius, the son of Frederick, Jr., and fell in love. Married in 1953, Ken and Bea lived together on Sycamore Street in Haddon Heights until Ken's death in 2016. Some of their descendants still live in Haddon Heights in 2022, including their granddaughters, Jennifer and Rachel Crecelius, and their great-granddaughters, Shannon Hagan and Giavanna Rossello.





This view of the station's gas pumps shows a custom sedan being serviced. This was a large, expensive car from a custom body shop. The rounded windows and body curves indicate it dates to no earlier than 1926; the slim-spoke artillery, detachable-rim wheel with small hubcap indicates it was manufactured before 1929. The smooth window surrounds are unusual for this period since most car windows were surrounded by decorative indents, often painted another color.

The Crecelius home stood to the left of the garage at 409 Black Horse Pike. Built in 1924, the house was demolished in 1972 for the construction of a Wawa Food Market, and is now the location of a karate academy.

<u>FAIRFIELD ESTATES</u>. Do you live in Fairfield Estates? Wait a minute.... Is that the development from "Back To The Future?? Why is this guy asking about some other town? If you grew up or now live on the west side of town near the Black Horse Pike, you may have spent time in the area formerly known as "Fairfield Estates". Back in 1924, citizens of this unincorporated area between Haddon Heights and Mt. Ephraim, petitioned Haddon Heights to become part of our town. There was much debate and discussion as Haddon Heights was a relatively new town, only incorporated in 1904. Read on, to see the letter about this proposal, sent to Haddon Heights residents by the Borough Council and distinguished citizens.....

Shall We Annex Fairfield?

December 17, 1924

Dear Voter:

The people living in the Fairfield estates between Haddon Heights and Mt. Ephraim have petitioned our Town Council for annexation, with the understanding they carry their own abutting property improvement costs.

This is an opportunity for the citizens of Haddon Heights to protect themselves from mounting costs of town and school maintenance by adding 1,392 taxable properties to the borough.

A locomotive with power to pull a train of forty loaded box cars is unprofitable if pulling only twenty.

We have town and high school equipment to serve three times our population, and this annexation would in a few years utilize that full equipment, and make us unafraid of new high schools erected in Audubon, Laurel Springs, or elsewhere. The additional ratables will stop an ascending tax burden on every property in the old and newly added parts of town.

The enclosed tabulation is authentic. Study it, bring it with you to a Town Meeting held in the new High School Auditorium, Friday evening December 19, 8:15, at which time our Councilmen will be guided by the vote of that meeting on this question. Ask questions at this meeting. Find out what this proposed annexation means to your pocketbook and then vote as your conscience guides you.

No more important Town Meeting was ever called in Haddon Heights. We must act quickly or lose this opportunity for all time.
